They are requesting Final Approval for a Planned Residential Development (PRD) for 30.29A. part of GB-542-6 (Century Ridge Estates). Legal Description: This 30.29A is part of the SW ¼, of the NE ¼, of Sec. 35, T25N, R22E, Town of Green Bay, Brown County, Wisconsin.

Chairman Dechamps called the meeting to order at 6:40.

Discussion and explanation with Cory McGinnis.

Supervisor Saharsky asked Mead and Hunt to generate a map of the PRD for future reference for lot 1.

Cory McGinnis reviewed the letters from Brown County.

Steve Heim – questioned the drainage ditches – they are in the center – right in the middle

Supervisor Saharsky – made mention of Page 73 #5 – page 72 #5/ regarding Drainage

Motion made by Supervisor Saharsky to close the floor. 2<sup>nd</sup> by Supervisor Dequaine. Motion Carried. 3-0

Supervisor Saharsky outlined options. Further Discussion held.

Have Tim Busch look at this and come up with an alternative – more detention regarding the pond  
Board is asking for more information.

Chairman Dechamps appointed Supervisor Saharsky to be the go between - between Joe Dietl and Tim Busch.

Supervisor Saharsky made a motion #1 to address the concern of the detention pond of the northern section of the development referred to in the letter of Brown county Planning #2 Final Letter from Brown County about the Storm Water Management Plan and Final Approval by April Mielke, Senior Management Plan, #3 Map concerning dedication of the land for extension of Depeau Rd, and addressing items #3 and #4 in the letter from Brown County regarding their Storm Water Management Plan. 2<sup>nd</sup> by Supervisor Dequaine.
