**Minutes of Public Budget Hearing Meeting
Tuesday, November 10, 2009**

Time: 6:30 pm – 7:00 pm

Chairman Dechamps called the meeting to order at 6:30 pm
Clerk verified properly posted and published.

Chairman Dechamps stated the floor is open to the electors.

Gary Quinn – questioned the hwy state and local expenses – are there plans to re-build or repair any roads? Chairman Dechamps explained VanLaanen Road is on the road maintenance plan for next year. Maggie Jenny, Kayla Lane, Vagon Lane and Gomand Rd are also on the maintenance plan. Gary questioned when Edgewater Beach Rd would be repaired? Chairman explained Edgewater Beach Rd does need more than chip sealing. The concern however, is how the road will be repaired and still allowing traffic flow. Chairman Dechamps stated it will be looked at in the future.

Chairman Dechamps further explained the roads are rated annually with an outside source. This road rating determines how the roads are prioritized.

Motion made by Dawn Goodman to accept the proposed Budget Summary. Second by Bob Boncher. Motion Carried.

Hal Goodman made a motion to approve the proposed highway expenditures for 2010 with a second by Debbie Delveaux. Motion Carried.

2. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy will exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the town tax levy for the past year by 51.933 percentage which would be a dollar increase of \$146,664 over the town tax levy for 2008 of \$282,410.

Motion made by Gary Quinn to approve the resolution 2009-3 to exceed the levy limit. Second by Dawn Goodman. Motion Carried.

3. To approve the 2009 town tax levy to be paid in 2010 pursuant to Section 60.10 (1)(a) of Wis. Statutes.

Motion made by Bob Boncher to approve the tax levy of \$429,074 for 2010. Second by Gary Quinn. Motion Carried.
