Constable DuBois stated Mr Osell was quite co-operative but nothing had been moved yet on this date. Constable DuBois said he has 2 weeks to comply.

Sup DeBroux stated there was an accident on County Line Rd, two tractors were involved in the accident, he stated the town had to fix the shoulder, Sup DeBroux contacted Theys Trucking and Excavating, \$808 was the charge of the repair of the road. The damage was on the section of the road we are responsible for. Chairman

Dequaine stated he had called Brown County to repair the sign that was damaged in the area of that accident. Chairman Dequaine stated he had received comments regarding the approval of the ditch cutting. Clerk gave Board info on the TAP Grants, LRIP grants, Farmland Preservation land owner application deadline, and discussed the WI Town's association meeting which will provide a speaker with an update for ARPA funds; also provided a letter regarding the deadline for the usage of the ARPA funds.

A. Open Floor for Public Comment

Motion made by Sup Bosman to open the floor with a second by Sup DeBroux. Voice vote 3-0 Motion Carried. John Metzler provided maps to the Board regarding a preliminary proposed future road off of Diesel Ct. Board requested a paper with the proposed plans prior to starting any construction and also mentioned the Board would have to have a final engineer approval before acceptance of the road. Motion to close the floor made by Sup DeBroux with a second by Sup Bosman. Voice vote 3-0 Motion Carried.

11. Clerk and Treasurer Reports

Treasurer read the report total balance on hand as of month-end August 2021 \$486,991.97 which includes the Brown County Tax funding and Recovery funds. Income for the month of August totaled \$104,726.57 and the Expenses totaled \$130,444.87. Totals agree with Clerk report. Motion made by Sup Bosman to accept the Clerk and Treasurer reports as presented. Second by Sup DeBroux. Voice vote 3-0 Motion Carried.
