1. Call to Order

Chairman Dequaine called the meeting to order at 7:00 pm. Opened the meeting by citing the Pledge of Allegiance.

2. Review and Take Action on July meeting minutes

6. 45 mph Speed Limit Request

Pat and Mike Donovan, residents of Seidl Rd off of CTH P were present, they stated they are looking to know what the steps would be to lower the speed limit on Seidl Rd, they questioned how would they get started on lowering the speed limit? Chairman Dequaine stated the town has the authority to put the speed limit down, but the issue is enforcing it. Pat stated they feel if they decreased it to 45 mph, people may take Hwy 54 instead of Seidl Rd. Pat stated there is no shoulder, and many people try passing; it is dangerous.

Chairman Dequaine stated he agrees it is a heavily traveled road. Chairman stated they can look into it and have it monitored. Sup Bosman stated they would have to contact the Town of Humboldt and Chairman Dequaine stated the Town of Luxemburg as well. Chairman Dequaine will look into it. Sup Bosman will contact Town of Humboldt and the Town of Luxemburg.

7. Temporary Liquor License for St Joseph's Parish

Chad Liebergen and Jennifer Jandrin present, the parish picnic is Sunday, September 14th. Sup Bosman made a motion to provide the parish with a temporary liquor license for St Joseph's Parish for September 14, 2025. Chairman Dequaine second the motion. 2 Aye 0 Nay Motion Carried

Chairman Dequaine gave an update regarding Crow Rd, Scott Construction will be starting within the next couple of days. If anyone wants a plat book they can be ordered. Chairman received a call from someone on Shore Acres, they have a community well and they are having problems, they wanted to know if they could hook up to city water, Chairman stated city water stops at Red Banks. They would either have to dig individual wells, it would have to be engineered, but it is private, so they are on their own. Clerk stated Brown County Municipal Court date will be November 6th. Clerk stated there will be some election items on next month's agenda. Clerk stated she spoke to Brown County Planning Dept regarding re-doing the zoning map, they would be able to assist. The fee would be for time and materials.
