# 7. Discussion regarding Brown County request to vacate portion of Bayshore Park Rd

Chairman Dequaine stated there will be a ranger station and some other changes, the Board explained, the County would take care of the legal fees associated with it; the town would no longer have to maintain it, we would no longer get state aid, but it would be minimal as the road is not that big. # 8. Rezone Request GB-39 (Zoning Petition #214-M) from B-1 Community Business to E-R Estate Residential/VN Sisters Support Association – 6028 County Rd K, New Franken

# 13. Correspondence Received

Chairman Dequaine received another letter from someone logging on N New Franken Rd, Pfaff. He further stated Crow Rd has been paved and it looks nice. He stated there are new signs on VanLanen and CountyLine and CTH P and a sign put on Seidl Rd and Countyline Rd and he also had to contact the sheriff regarding the trailer on Gravel Pit Rd, which has become a hazard concern. He explained there has been more garbage dumped in the town, a couch, chair, bed sheets, on VanLanen Rd. Discussion was held on how we can try to deter people from dumping garbage on the roads in the town. Possibly post photos if happens again in the future to see if anyone would have any information on who may be doing this.

Sup DeBroux stated the Town of Green Bay is hosting the Town's Association meeting this coming Thursday. Sup Bosman got a call from Enderby's regarding a dead ash tree caused a full road closure, Rockwood Point Rd, walleye guts on the edge of the road, resident buried the fish, Mr VandenPlas stated on Old Country Circle black dirt was dumped in the ditch, the land owner will have to take it down to where it was before it was put in the ditch. Clerk stated there was a new Highway Dept schedule received, Board verified receipt of the new schedule. Chairman Dequaine explained the toilet in the men's bathroom had been running and it overflowed, he cleaned it up and had a plumber come to put new seals in.
